



BUILDING PERMITS

You will be fined \$100.00 plus double the cost of the Building Permit if you start work without obtaining a Building Permit. NO EXCEPTIONS.



A building permit must be obtained <u>prior</u> to the construction, alteration/remodel or repair of any house/property whether doing the work yourself or by a contractor. Permits are needed for, but not limited to, the following: alterations involving moving or adding walls, basement finish-out, electrical and plumbing work, HVAC work, shed, fence, deck, patio, roof, driveway, window replacement, siding, solar panels, swimming pool. <u>If you're not sure if a permit is required, please call the Village Office at 708-788-3429</u>. Some building permits require a fee, however many projects there is no fee at all for the permit.

Permits are required to ensure that the work adheres to Forest View Building Codes. Also permits can guarantee that a contractor is insured and bonded and the homeowner is protected from fraud.

Before You Dig, Call (or Click) JULIE

If you are planning an outdoor project, call JULIE before you dig to avoid injury and/or damage to underground utilities. Simply call 811 or 1/800/892-0123. The call is free and so are the services. Call center representatives are available 24 hours a day, 7 days a week. Or you can log on to www.illinois1call.com

GARAGE SALES

Due to the COVID-19 Pandemic, the homeowner is responsible for following masks and social distancing guidelines per State CDC.

Spring/summer cleaning in many cases means garage sales. Just as a reminder, sales are limited to two (2) per household per year. There is no fee to hold a sale, but a permit is required. Permits should be obtained at the Village Office three (3) days prior to the planned sale. Sale hours are limited between the hours of 9:00 a.m. and 5:00 p.m. and sales cannot last more than three (3) consecutive days. Regular items found around the house are allowable in garage sales; however, arts and craft items are not. All advertisements must be removed from the parkway within 24 hours of the completion of the sale, and at no time are signs to be placed on street light poles, stop signs or parking signs.

ANNUAL DOG LICENSE



We would like to take this opportunity to remind all residents that per Village Ordinance all dogs must be registered annually with the Village Office and wear an upto-date dog identification tag. The annual fee of the dog license/identification tag is \$1.00. To obtain a license, owners must show proof of a current rabies vaccination. No more than three (3) dogs are allowed per residence.

To make it both *easier to remember* and *more convenient*, dog licenses and vehicle stickers are being sold the month of June.

So, no matter when you registered/purchased your dog license/tag in calendar year 2020, you are required to purchase a 2021-2022 tag by June 30, 2021.

If you haven't purchased a current 2021-2022 dog license, please be sure to stop by the Village Office soon! Failure to purchase a dog license in June each year will result in a \$50.00 citation per dog for being in violation of Village Code.

VEHICLE STICKERS

All vehicle stickers for 2021-2022 are due on June 30, 2021 and are to be displayed on your windshield no later than July 1, 2021.

The vehicle sticker price for a passenger car is \$10.00; senior citizens 65 and older the fee is \$2.00 (one per household). Stickers purchased after due date, an increasing monthly late penalty will be imposed. Vehicles not displaying a current village sticker as of July 1st are also subject to enforcement action. Stickers may be purchased at the Village Office Monday thru Friday during the hours of 9:00 a.m. to 5:00 p.m.

If during the year you purchase another vehicle, please remember to stop by the Village Office to transfer or purchase a sticker, whichever the case might be.

4th of JULY



This Community Notification is being given to all residents of Forest View as a means of communicating the law concerning the possession and discharge of fireworks within the Village and the actions and enforcement you will be seeing over the 4th of July Holiday.

For the Safety and Wellbeing of our residents, the Forest View Police Department will be enforcing state and local fireworks ordinances.

The Illinois Pyrotechnic Use Act (PUA) bans the sale, possession and use of all consumer fireworks that can be bought illegally in some states such as firecrackers, bottle rockets and roman candles. Possessing, selling and using consumer fireworks may be punishable by a fine.

Novelty fireworks, such as sparklers, snakes, party poppers and caps are not regulated but are available for retail purchase in Illinois. Young children should be supervised when using sparklers, which can reach temperatures of up to 1800 degrees Fahrenheit. The sparkler wire also presents a serious danger because of the high temperature of the wire during and after use.

Forest View residents can call 911 or the nonemergency police number at **708-458-2191** (use your best judgement) to report excessive use of illegal consumer fireworks.

Our goal is to keep fireworks out of the hands of children, reduce the number of fireworks-related injuries and fires, and curtail the illegal possession and discharge of fireworks.

MOVE OVER LAW SCOTT'S LAW

With the rise of state troopers killed on the side of the road, Scott's Law is being more strictly enforced.

While drivers may be familiar with the Move Over Law as it applies to emergency vehicles and maintenance workers, many do not know that in Illinois, this law was expanded January 1, 2017 to require passing drivers to slow down and change lanes when approaching ANY vehicle with hazard lights flashing. Drivers who fail to comply with Move Over Law face serious penalties. Should you be stranded on the side of the road with your hazard lights on, the Move Over Law is intended to protect ALL OF US.



FREE - VACATION HOUSE SECURITY CHECKS

Welcome to summer! This is the time that most people take vacations. Remember to make sure that your house is secure and that either your mail is stopped, or that someone can collect your mail until your return, and make arrangements to have your lawn cut. Also, put your house lights on timers, and have neighbors keep an eye on your house. Another safety precaution, do not post travel plans on Facebook or post vacation pictures while away. Please inform the police department when you are leaving and returning and we will do physical checks of your home. Or, if you prefer, we can just do drive-by surveillance. Please stop by the police department to let us know your preference.



LAWN MAINTENANCE

Homeowners can help keep our community neat and attractive and reduce harborage areas for

unwanted rodents by regularly mowing their lawns. Please refrain from mowing/diverting the grass into the street as it will clog up the storm sewer system. Village Code requires that grass and weeds be maintained at a height of five inches (5") or less. Grass/weeds that are neglected and allowed to grow longer than 5 inches is considered a nuisance and the Public Works crew may cut and bill property owner or lessee \$150.00 for the 1st cutting and \$325.00 for subsequent cuttings during the same calendar year. This Code is strictly enforced. Please be considerate of your neighbors and community by keeping your lawn mowed.



PARKWAY TREES

Parkway trees are Village-owned. Therefore, property owners are prohibited from trimming parkway trees. Please contact the Public Works Department at 708-788-3429 if you have any concern regarding a parkway tree.

Please Advise Your Landscaper

Please advise your landscaper...... DO NOT rake or blow your leaves into the street. When it rains, this clogs up the sewer inlets and flooding can result. Therefore, please advise your landscaper to place leaves in a garbage can with a Compost Sticker (available at the Village Office free of charge) affixed to the can or to bag the leaves in paper yard waste bags.

Now that summer is here we want to get out and enjoy the nice weather. We still need to keep safety in mind. One of the things I would like to talk about is fire pits. I know a lot of residents have them or are thinking about getting one for the yard. Here are a few things to keep in mind with fire pits:

- Never leave it unattended. An adult should be present when the pit is lit and burning.
- Don't allow other adults or children to play around the pit. Someone can fall into the area of the pit and get hurt.
- Have your garden hose close to the pit when its burning. Extinguish the fire when you are done with it.
- Allow time for it to cool before starting clean up. Hot ashes will cause secondary fires.

Fireworks are illegal and please follow the police guidelines. Be cautious when allowing the use of sparklers. They are a novelty firework typically given to children, but they burn at 1800 F. When placed against clothing or skin, it can cause serious injuries. Please watch your children with them, and leave the fireworks to the professionals. Let's be safe and have a good Fourth of July.

A Fun recipe to share......



Start your morning with a grassy, green kick!

ou may have heard a lot these days about matcha, the bright green powder making its way into mugs, lattes, and desserts around the world, and maybe even a café near you. But what exactly is matcha? And where did it come from?

Matcha is a tea, and it has a rich history. Since the 10th century, matcha has been used in Japanese tea ceremonies called "chanoyu." Matcha and green tea both come from the *Camellia sinensis* plant, but to grow matcha, farmers will cover the tea plants to avoid direct sunlight before harvest. This increases

chlorophyll production and gives matcha its distinctive green hue. After the tea leaves are harvested, the stems and veins are removed, and what's left is ground up into a powder. This antioxidant-rich powder is then whisked into hot water (traditionally) or milk and sweetener (like you'd find at Starbucks).^{1,2}

Like loose-leaf tea, matcha has a grassy, herbal flavor; however, it is considered to be less astringent and smoother than regular green tea. There are two main grades of matcha available today: traditional or

"ceremonial" grade and culinary grade. Traditional matcha is made from the youngest tea leaves, and is the best for drinking straight. Culinary matcha is made from older green tea leaves and is best used for cooking, flavoring cakes, or blending into smoothies.²

Unsure of how to bring this chartreuse comestible into your kitchen? For the best flavor, start by purchasing a high-quality matcha powder. Then, whip up one of these delicious beverages.

How to Make Matcha Serves 1 Ingredients 1/4-1 teaspoon matcha (depending on your

- ¼-1 teaspoon matcha (depending on your preference)
- 2 ounces boiling water
- 6 ounces additional boiling water or steamed milk of choice (almond milk, oat milk, coconut milk, dairy milk, etc.)
- Maple syrup, honey, or aother sweetener (optional)

Sift the matcha into a mug or small bowl to get rid of any lumps.

Pour in the 2 ounces of boiling water. Using a matcha whisk or small regular whisk, whisk briskly from side to side until the matcha is fully dispersed and there is a foamy layer on top.

Add the remaining 6 ounces of boiling water or steamed milk and whisk again until foamy. Sweeten to taste, if desired.

Serves 1

Ingredients

- 1 cup unsweetened almond milk
- 2 scoops (39.8 grams) vanilla protein powder
- 1/2 cup ice
- 1 banana
- 2 teaspoons matcha green tea powder
- 1/2 teaspoon maple syrup
- Fresh vanilla bean, scraped from 1 inch of a pod

Combine all ingredients in a blender and mix until smooth.

** The Board meets in the Municipal Building on the second and fourth Tuesday of the month and the meetings begin at 7:00 P.M and are open to the public.**

April 13, 2021

Superintendent O'Donohue recommended approving the quote from Magana Concrete to repair / replace concrete at various locations in town.

Village Administrator Masciola spoke regarding permits. There are approximately fifteen active commercial projects at this time.

April 27, 2021

Village Administrator Masciola mentioned that Old Dominion turned in a new set of plans to rebuild their existing dock area. The plans were given to FSCI for review. This is the area where they had the roof collapse back in February. The project is valued at ten million dollars.

Village President Nancy L. Miller and Village Trustees Richard M. Hubacek, Mark E. Augspurger and David Liska were sworn in.

Village President Miller received a gift from Tanner Miller, thanked everyone who voted and thanked everyone for their support. Village President Miller mentioned that she is looking forward to a fun-filled and prosperous four years. She has many exciting things planned and is hoping everyone can come together to accomplish them. Village President Miller will try and make it a point to be in the Village Office in the evenings after her full-time job. She also noted that everyone is welcome to call and set up an appointment with her, or feel free to just drop-in.

May 11, 2021

Village Attorney John Murphey swore in Maria A. Ramirez as Village Trustee. She will finish the balance of Village President Miller's two-year term in office as Trustee.

On Friday April 30, 2021, a large branch fell off of a parkway tree onto a fence at 4601 Kenilworth. Public Works did cut the fallen branch and remove it off of the property.

This week we received the new Scott Air-Pak's. We have the company doing service training this week and next week. The Air-Pak's should be in service the following week.

May 25, 2021

President Miller presented a letter regarding Resolution # 21-05 supporting the restoration of Local Government Distributive Fund (LGDF) revenue urging the Governor to restore LGFD payments to the promised 10% rate so the municipalities across Illinois may provide basic levels of service and lessen the reliance on property taxes.

Superintendent O'Donohue spoke regarding the water rate increase. The City of Chicago has informed the Village of a 1.10% water rate increase which will take effect June 1, 2021. The increase would be reflected on the October 2021 residential bills based on water usage from the end of July and thereafter.

Village President Miller spoke regarding the Village Clerk and Village Treasurer positions. In the interest of making the appointment of a

Village Treasurer more appealing, and to facilitate a better transition of board activities, Village President Miller would like to ask the board to consider making a change to Village Clerk and Village Treasurer positions. It would be beneficial for one individual to address the needs of both the Village Clerk and Village Treasurer rather than hire two people for these positions separately. In doing so, this would allow us to have someone in an appointed position who would be available to handle all clerking and treasurer duties as assigned.

Regarding the seven OSHA violations, six have been rectified. OSHA has retracted the six out of seven violations. We should be able to rectify the seventh violation before the June 11, 2021 deadline.

Illinois Department of Transportation has sent a pre-construction letter regarding the replacement of the bridge structure northbound on Harlem Avenue, over MWRD, the Greater Chicagoland Railroad and the Village of Lyons. Work should start early June 2021.

June 8, 2021

President John Graham of Graham Enterprise, Inc. presented a proposal to the Village Board regarding an investment opportunity for economic growth. He has proposed the option of investing in the expansion / project which would potentially increase revenue through taxes for the Village of Forest View.

Village President John Murphey requested that Graham Enterprise submit a proposed agreement or proposed concept with specific projections on local sales tax shares and property tax for the Board to review.

Howard Gadorus from Mercury Solutions spoke explaining the intercom system in the Police Department. By removing the old system, we would need something to control the doors and intercom system. It was explained that there are options available. He spoke regarding forwarding phone numbers to Justice, installing a network, converting numbers and options to complete the 9-1-1 transfer.

Regarding Annual Fire Inspections for the businesses in town, Lieutenant Rick Musil (Fire Prevention Officer) has come up with a plan to inspect seven (7) businesses per month starting July 1, 2021. He will follow up with the businesses for reinspection.

The Board was notified of the passing of longtime resident Stanley Zajac. We came across a Resolution from 2016 Honoring Stanley Zajac on the Occasion of his Ninetieth (90th) Birthday, and here are some of the highlights from the resolution:

- Stanley was a longtime resident of Forest View.
- Stanley has been a fine, upstanding citizen of the Village of Forest View.
- The Village has benefited by the services faithfully and efficiently performed by Stanley as a Translator for the Village and a Bingo caller for the Village Picnics.
- Stanley was an active member of the Golden Panthers.
- Stanley was a Volunteer Firefighter and Police Officer.
