AN ORDINANCE FORMALLY APPROVING AND ANNEXING TERRITORY PURSUANT TO A PLAT OF DEDICATION FROM TRUST NUMBER 7108 ("TRUST") TO THE VILLAGE OF FOREST VIEW ("Village"), COOK COUNTY, ILLINOIS

- **WHEREAS**, on March 11, 2022 a Plat of Dedication was executed by the Trust of territory formerly owned by Combined Property ("Property"), a copy of which is attached hereto and made a part hereof; and
- **WHEREAS**, the Property is not within a municipality but is contiguous to the Village and has no electors; and
- **WHEREAS**, with this Dedication extends 49th Street to Central Avenue and therefore facilitates the installation of traffic signals; and
- WHEREAS, it is in the best interest of the Village and its citizens that said dedicated property be annexed;
- **NOW THEREFORE, BE IT ORDAINED** BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF THE VILLAGE'S HOME RULE POWERS, as follows:
- <u>Section 1</u>. That the territory legally described on the Plat of Dedication as attached to and made a part of this Ordinance is hereby annexed to the Village of Forest View, Cook County, Illinois (See Exhibit "A").
- <u>Section 2</u>. That the Village Clerk is hereby directed to record with the Recorder of Deeds, Cook County, Illinois and to file with the County Clerk, a certified copy of this Ordinance, together with the accurate map of the territory annexed appended to said Ordinance.
- <u>Section 3</u>. If any action, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity shall not affect any of the other provisions of this Ordinance.
- <u>Section 4</u>. This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided for by law.
