AN ORDINANCE AMENDING TITLE 9 OF  
THE FOREST VIEW VILLAGE CODE, "TRAFFIC"

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF THE VILLAGE'S HOME RULE POWERS, as follows:

**SECTION 1: Amendment of Section 9-3-2.** Section 9-3-2 of the Forest View Village Code, "Stop Streets," is hereby amended, in part, by adding language as represented by underlined bold type and deleted language as represented by a ~~strike through~~ as follows:

The Chief of Police is hereby directed to erect appropriate signs as indicated herein to effectuate the purposes of this section. The following described intersections are hereby designated as stop intersections:

Home Avenue and 45<sup>th</sup> Street.

Home Avenue and 46<sup>th</sup> Street. (Ord.59-18A, 7-28-1959)

Oak Park Avenue northbound to stop for 45<sup>th</sup> Street. (Ord.86-9, 7-8-1986)

Wenonah Avenue to stop for 45<sup>th</sup> Street, going north.

45<sup>th</sup> Street to stop for Wenonah Avenue, going east. (Ord. 69-209. 12-23-1969)

46<sup>th</sup> Street and Home Avenue in all directions, within a park zone street. (Ord. 06-16, 7-11-2006)

46<sup>th</sup> Street to stop for Kenilworth Avenue, east and westbound. (Ord. 85-8, 7-9-1985)

46<sup>th</sup> Street to stop for Maple Avenue, east and westbound. (Ord. 77-17, 11-1-1977)

46<sup>th</sup> Street and Oak Park Avenue. (Ord. 69-195, 7-8-1969)

Maple Avenue northbound to stop for 45<sup>th</sup> Street. (Ord 18-13, 10-23-18)

Wisconsin Avenue northbound to stop for 45<sup>th</sup> Street. (Ord 18-13, 10-23-18)

Clinton Avenue northbound to stop for 45<sup>th</sup> Street. (Ord 18-13, 10-23-18)

Kenilworth Avenue northbound to stop for 45<sup>th</sup> Street. (Ord 18-13, 10-23-18)

Grove Avenue northbound to stop for 45<sup>th</sup> Street. (Ord 18-13, 10-23-18)

46<sup>th</sup> Street to stop for Clinton Avenue, east and westbound. (Ord 18-13, 10-23-18)

**46<sup>th</sup> Street to stop for Wenonah Avenue, east and westbound.**

**SECTION 2: Home Rule.** This Ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the Village of Forest View that to the extent that the terms of this Ordinance should be inconsistent with any non-preemptive state law, that this Ordinance shall supersede state law in that regard within its jurisdiction.

**SECTION 3: Full Force and Effect.** This Ordinance shall be in full force and effect from and after its passage and approval, and shall subsequently be published in pamphlet form as provided by law.
