**BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW AS FOLLOWS:**

**SECTION 1: Donation.** The President and Board of Trustees of the Village of Forest View hereby approve of the donation of the Village's interest in the following described real estate in Cook County, Illinois, to the people of the State of Illinois Department of Transportation for highway purposes for the sum of \$0:

PARCEL 2, ILLINOIS STATE ROUTE FAP 366 DEDICATION (P.I.N.: 19-08-203-044):

THAT PART OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 8, TOWNSHIP 38 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE NORTH LINE OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 8, 50 FEET WEST OF THE NORTHEAST CORNER THEREOF; THENCE SOUTH 01 DEGREES 34 MINUTES 37 SECONDS EAST, PARALLEL AND 50.00 FEET WEST OF THE EAST LINE OF SAID NORTHEAST QUARTER A DISTANCE OF 59.00 FEET; THENCE SOUTH 88 DEGREES 06 MINUTES 24 SECONDS WEST, PARALLEL WITH SAID NORTH LINE OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 8 A DISTANCE OF 31.00 FEET TO A POINT ON A LINE LYING 81.00 FEET WEST OF AND PARALLEL WITH THE EAST LINE OF SAID NORTHEAST QUARTER; THENCE NORTH 01 DEGREES 34 MINUTES 37 SECONDS WEST ALONG SAID PARALLEL LINE 59.00 FEET TO A POINT ON SAID NORTH LINE OF

THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 8; THENCE NORTH 88 DEGREES 06 MINUTES 24 SECONDS EAST ALONG THE LAST DESCRIBED LINE 31.00 FEET TO THE POINT OF BEGINNING, IN COOK COUNTY, ILLINOIS.

**SECTION 2: Authorization.** The Village President and Village Clerk are hereby authorized and directed to execute and attest respectively such instruments as may be necessary or convenient to consummate the property transfer authorized by this Resolution.

**SECTION 3: Effective Date.** This Resolution shall be in full force and effect immediately upon its adoption.
