**WHEREAS**, the Village of Forest View is committed to fair and competitive compensation for all Village employees; and

WHEREAS, the Village President and Board of Trustees have determined that it is in the best interest of the Village to amend the current Salary Ordinance to adjust the hourly compensation for the position of Part-Time Public Works Maintenance Worker, including janitorial employees, within the Public Works Department; and

WHEREAS, such amendment is necessary to ensure appropriate compensation for weekend events and holidays;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village

of Forest View, Illinois as follows:

# **SECTION 1:** Amendment to Salary Ordinance

That Part C – Public Works Department, #5 – Part-Time Public Works Maintenance Worker, of the Village Salary Ordinance is hereby amended and shall read as follows:

Part-Time Public Works Maintenance Worker:

The Part-Time Public Works Maintenance Worker, including janitorial employees, shall be compensated at twenty-one dollars and thirty-four cents (\$21.34) per hour for regular hours worked.

Compensation for work performed during weekend events and holidays shall be at a rate of thirty-two dollars and one cent (\$32.01) per hour, which represents time-and-a-half compensation.

# **SECTION 2:** Severability

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity
